

Its areas of responsibility are:

- Combating money laundering
- Granting of operating licenses to financial entities in Switzerland
- Financial restructuring and bankruptcy proceedings
- Overseeing that the aforementioned entities comply with with required regulations

FINMA's actions help protect clients and strengthen confidence in the smooth functioning, competitiveness and integrity of Switzerland's financial market.



PolyReg is a self-regulatory body recognized by the FINMA and established according to Article 24 of

the Swiss Money Laundering Act and acts as a regulatory and supervising organization for its members.

Asset managers must, at minimum, comply with the rules and regulations of their respective self-regulatory body. In the case of WM, PolyReg which can be found on www. PolyReg.ch required regulations FINMA's actions help protect clients and strengthen confidence in the smooth functioning, competitiveness and integrity of Switzerland's financial market.



WM is authorized to distribute collective investment schemes (e.g. funds and ETFs). The Swiss Collective Investment Schemes Act (CISA)

requires an authorization for the promotion of collective capital assets and forbids, under penalty of law, the public promotion of such assets without authorization WM is certified by PolyAsset to market collective capital assets and subject to PolyAsset Code of Professional Conduct.


Maria Roumy is an internationally minded French national and fluent in English, French and Arabic. She holds a business degree from the International University of Monaco.


YOUR RELATIONSHIP WITH WM
